All international student applicants are required to submit verification of financial support for the duration of their studies. The verification form along with all supporting financial documents must be submitted to the Admissions Office before a SEVIS form I-20 will be issued. Mail correspondence to Admissions Office, Daytona State College, 1200 W. International Speedway Blvd. Daytona Beach, FL 32114.

Keep copies of all financial support documents for your records.

FINANCIAL SUPPORT DOCUMENTS

Submit supporting financial documents to the Admissions Office. These documents help to validate all of your sponsorship sources. Supporting documents **must be in English, currencies in U.S. dollars,** and must be **no more than six months old** from the date you plan to begin classes. A new verification of Financial Support will be required if you change programs. Following is a list of acceptable financial support documents:

Please DO NOT submit bank statements.

- Personal funds Submit a <u>bank letter</u>, or c<u>ertificate of deposit</u>, on bank letterhead that includes your name and the current balance in U.S. dollars or stating that there are funds in excess of the estimated cost of attendance (specify exact dollar amount).
- Individual sponsors (family, friends, etc.) Submit a <u>bank letter, or certificate of deposit</u>, that includes the sponsor's name and the current balance in U.S. dollars or stating that there are funds in excess of the estimated cost of attendance (specify exact dollar amount). Submit with a signed Affidavit of Support (below) for each sponsor.
- Government sponsor Submit an award letter from the sponsoring government.
- Daytona State College If Daytona State will be providing you any funds such as an athletic scholarship, those documents must be attached..
