



Daytona State College requires that all degree and certificate-seeking students submit final, official high school or GED transcripts and transcripts from all postsecondary institutions previously attended. This requirement ensures that Daytona State meets high academic standards by taking each student's full academic history into account.

Students who have transcripts from outside the United States are required to submit a final, official **evaluation** of their transcripts. Evaluations must be performed by a member of the National Association of Credential Evaluation Services (NACES).

High School Transcripts

Submit a document-by-document evaluation.
or
Submit a course-by-course evaluation if you graduated high school in a country where the official language is English and you wish to be granted credit for having completed two years of a foreign (non-English) language. This credit can be used to satisfy the foreign language requirement of some degrees. Please consult an Admissions Advisor for more information.

College/University Transcripts

Submit a course-by-course evaluation and translated course descriptions /syllabi for each class you wish to have considered for transfer. Transfer of courses is based upon course content equivalency, credit hours earned, and grade earned.
