Apprenticeship Program Requirements

- Experience is not necessary
- Must be 18 year of age or older
- Must have a Florida Driver's License or State of Florida Issued ID
- Must be a High School graduate or equivalent
- Must be physically able to perform the duties of the trade
- Math, Science and Algebra is strongly recommended, but not required.
- Mid-Florida Non-Union Electrical Apprenticeship and Training Committee must select first-year apprentices, before beginning the program.
- You must be working for one of our participating contractors to be enrolled in the program.

Our Program

The Mid Florida GNJ Electrical Non-Union Apprenticeship provides motivated individuals the opportunity to learn a trade by working under the supervision of a skilled craftsman and attending related classroom training. Apprentices receive excellent wages, benefits, state-of-the-art training, and advancement opportunities.

If you enjoy working with your hands in all types of conditions and are looking for an alternative to a four-year college degree, consider apprenticeship training. Apprenticeship programs offer the best of both worlds – paid work experience and related educational instruction. This apprenticeship will prepare you to become a skilled electrician, acquiring the necessary knowledge and abilities to pursue a career as a journeyman electrician.

Earn while you learn.

In a registered apprenticeship program you don't just sit in class listening to someone spout theory, waiting for the day when you can start getting a paycheck. Apprenticeship programs combine classroom instruction with on-the-job training. What you learn in class you get to put into action right now – not somewhere down the line – on a real job with a real paycheck. Plus, if you're in a field that required licensing, apprenticeship is the key that will help you ace the required exam. And that license belongs to you – not the company. It goes with you if you decide to move on to another job.

Program Description

The Mid-Florida Electrical Non-Union Apprenticeship, GNJ Program is a state subsidized, four-year program. Apprentices in the electrical construction trade will be taught principles of electricity and magnetism, wiring, installation methods, first aid, safety issues, electrical motor theory and control. Apprentices receive extensive classroom and on-the-job training (OJT).

In most cases, a great deal of financial resources and energy are required to prepare for your career, but in a registered apprenticeship program, you are paid a progressively increased wage while you learn the occupation. The curriculum provides knowledge and skills training in all aspects of electrical construction work in the residential, commercial, and industrial markets. Apprentices are required to work a total of 8,000 hours of OJT and 792 class hours for successful completion of the program.

You will attend four (4) years of instruction at a State accredited school. These classes are held at the Advanced Technology College, which is part of Daytona State College. GI benefits are possible for veterans.

You will be required to attend classroom instruction consisting of two (2) nights per week, three (3) hours per night totaling one hundred ninety-eight (198) hours per year totaling seven hundred ninety-two (792) hours over 4 years. You will also have on-the-job training consisting of two thousand (2,000) hours per year totaling eight thousand (8,000) hours over 4 years.

Current Wages

- 1st year - \$9.75/hour
- 2nd year - \$11.00/hour
- 3rd year - \$12.75/hour
- 4th year - \$14.50/hour

After completion of school and licensing, wages should run from \$30,000 to \$50,000 yearly, depending on ability and productivity.
